### **New Business:**

**A.** Approval / Disapproval of Notice of Intent Ordinance No. 1228: authorizing the issuance of the Town of Silver City, NM Gross Receipts Tax Improvement Revenue Notes, Series 2014 in two series in an aggregate principal amount not to exceed \$1,500,000 for the purpose to (1) finance acquisition and construction of certain capital improvements for the benefit of the Town and its residents, including but not limited to, public safety equipment and public recreation facilities, and (2) pay costs of issuance of the Series 2014 Notes.

**B.** Approval / Disapproval of Resolution No. 2014-15: a Resolution authorizing the execution and delivery of a Colonias Infrastructure Project Fund Loan/Grant Agreement and Intercept Agreement by and among the NM Colonias Infrastructure Board and the NM Finance Authority and the Town of Silver City, in the total amount of \$361,306 evidencing an obligation of the Town to utilize the loan/grant amount solely for the purpose of financing the costs of construction of a sewer lift station to intercept the sewage flow at F Street and construction of a new pressure sewer line from the lift station along F Street.

**C.** Fiscal Year 2014-2015 Budget presentations by Judge Sonya Ruiz and Alex C. Brown, Town Manager-Finance Director, and request for Council's direction.

**D.** Approval / Disapproval of Notice of Intent Ordinance No. 1229: an Ordinance amending Town Ordinance No. 722 that was passed, adopted and approved by the governing body of the Town of Silver City, NM on August 30, 1984, relating to the imposition of fourth increment of Municipal Gross Receipts Tax.

**E.** Approval / Disapproval of Notice of Intent Ordinance No. 1230: an Ordinance amending Chapter 16, Article II (Economic Development Plan), Sections 16-21, 16-68, 16-69 and 16-72 of the Town of Silver City Code of Ordinances.
