

## LEGAL NOTICE

### TOWN OF SILVER CITY RESOLUTION NO. 2010-32

#### FOR THE REGULAR MUNICIPAL ELECTION TO BE HELD MARCH 1, 2011

Be it resolved by the Governing Body of the Town of Silver City that:

- A. A regular municipal election for the election of municipal officers shall be held on March 1, 2011. Polls will open at 7:00 a.m. and close at 7:00 p.m.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
1. District 1 — One Councilor for a two-year term.
  2. District 3 — One Councilor for a two-year term.
- C. Precincts are consolidated for the regular municipal election as follows:
1. District 1 Full and partial County Precincts located within the Town limits:  
Precincts 14 and 15
  2. District 3 Full and partial County Precincts located within the Town limits:  
Precincts 17, 18, 20, 21, 22 and 33
- D. The following locations are designated as polling places for the conduct of the regular municipal election:
1. Voters in District 1 shall vote at the Silver City Woman's Club, 411 Silver Heights Blvd., Silver City, New Mexico 88061.
  2. Voters in District 3 shall vote at the Silver City Senior Center, 205 West Victoria St., Silver City, New Mexico 88061.
- E. Absentee Voting.

Applications for absentee ballots may be obtained only from the office of the Municipal Clerk at City Hall, 101 West Broadway, Silver City, New Mexico. All applications for an absentee ballot must be completed and accepted by the Municipal Clerk prior to 5:00 p.m., February 25, 2011. After 5:00 p.m. on February 25, 2011, all unused absentee ballots will be publicly destroyed by the Municipal Clerk. The Municipal Clerk will accept completed absentee ballots delivered by mail, or in person by the voter casting the absentee ballot, by a member of the voter's immediate family, or by the caregiver to the voter, until 7:00 p.m. on March 1, 2011.

Absentee ballots may be marked in person in the Office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, January 25, 2011 and closing at 5:00 p.m. on Friday, February 25, 2011.

Early Voting. Early voting on paper ballots counted by M100 electronic vote tabulator will be conducted in the office of the Municipal Clerk during the regular hours and days of business,

beginning on Wednesday, February 9, 2011 and closing at 5:00 p.m. on Friday, February 25, 2011.

- F. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Grant County not later than Tuesday, February 1, 2011 at 5:00 p.m., the date on which the County Clerk will close registration books.
- G. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 4, 2011 between the hours of 8:00 a.m. and 5:00 p.m.
- H. The casting of votes by qualified municipal electors on March 1, 2011 shall be recorded on paper ballots to be counted by M100 electronic vote tabulators.
